with the support of a few Republicans who are threatened by Trump or angry at him.

The penalty for treason and insurrection can include death, sedition is a stiff fine, up to 20 years in prison, or both.

However, the United States Uniform Code of Military Justice provides the death penalty for soldiers convicted of committing sedition.

Trump posted on Truth Social a few statements to the effect that sedition calls for the death penalty. One guy said, Hang ‘Em, that’s what George Washington would do.” Trump reposted it! The left is going apoplectic over Trump’s statements and totally ignores what these democrats did in their seditious incitement to insurrection they sent out directly to military personnel.

You are violating the LAW. Your actions are UNLAWFUL — not Trump's, YOURS.

How about an update on the Comey saga?

Comey is not even trying to dispute the evidence of wrongdoing. His first line of defense is to disqualify the Prosecution and have his case thrown out on a technicality. The Grand Jury that indicted Comey had a clerical glitch that Comey tried to exploit. Apparently, there was some ambiguity on whether the Grand Jury actually, formally, voted on the indictment. Here's the problem. The Grand Jury acknowledged the discrepancy in the record and corrected it by directing that the corrected 2-count indictment be docketed. The court and the foreperson on the Jury confirmed the vote on the 2-count indictment, and the official transcript of the proceeding leaves no room for ambiguity.¹⁰

That must have slammed hard on Comey's head. The whole thing ended up strengthening the case against Comey. Now the Jury has doubled down on its indictment.

Habeas. (See the order here.¹²) This means the Supreme Court acknowledged the detainees' right to seek judicial review of the legality of their detention.
