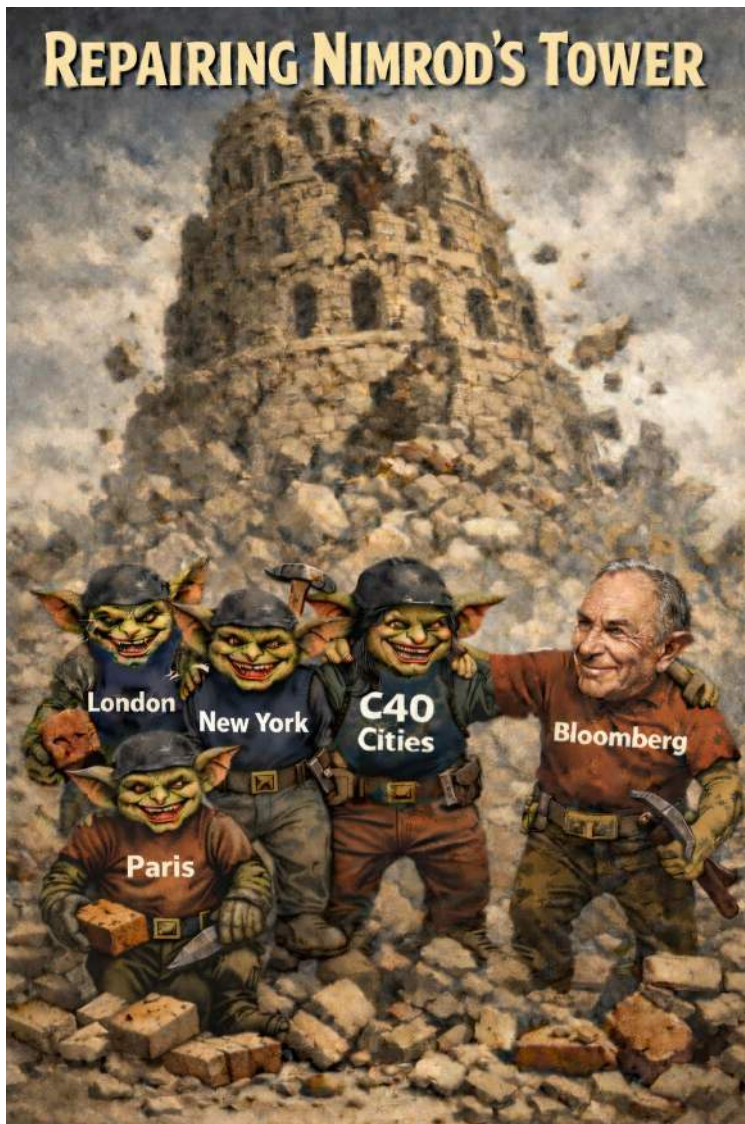

“Forbidding to marry, and commanding to abstain from meats, which God hath created to be received with thanksgiving of them which believe and know the truth.”

Commanding to abstain from meats? Interesting! What’s that? No one is “commanding you to abstain from meats”? Right! And no one was mandating vaccines, and no one was mandating masks, and — wait! That’s right, they were. They didn’t start that way, but they very soon went that way.

They always start with a recommendation, and when you object or don’t play along, then they go to arresting you and forcing you into some isolation camp (Australia), or fire you from your job (medical people and soldiers), or ban you from their stores, or kick you off an American Airlines flight if you wear a Trump mask! But that’s not all. These climate alarmists have a goal to restrict you to 8 new clothing items per person per year. Don't make the mistake of thinking this is some impossible scenario years away from implementation.

Oxford has implemented some C40 interventions (they call them *interventions*), such as ZEZ (Zero Emissions Zones), and they have committed to Zero Carbon emissions goals—their target to reach zero emissions is 2040.⁶ They have traffic filters on certain streets that require permits, limiting you to 100 passes per year for some and only 25 for others. If you exceed these limits, you get fined.

This is also a broad movement in the US: 35 of the 50 largest US cities have adopted local climate action plans, and they are taking the C40 recommendations seriously. Worldwide, almost 100 cities collaborate with the C40 Cities Climate Leadership Group, committed to cutting fossil fuel use in half by 2030.⁷

Many of these cities are actively considering implementing specific, draconian C40 interventions, while others are sympathetic to C40 Cities' overall goals.

Trump has broken the globalist tower! (See last show—Episode 1074.) Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse, your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church belfry arch, signaling the enemy is on the march—an enemy that would steal from us our liberty.

Election Integrity news! The DOJ has sued Virginia to compel the release of its voter rolls. Virginia has to be sued by the Department of Justice to release their voting rolls because, what, they are still fighting the Civil War?

When it comes to Federal Elections, the Federal Government has a legitimate interest in policing elections for the people's federal officers, such as Congressional and Presidential elections. The Executive and Legislative Branches have a responsibility to intervene if there is any suspicion of State negligence in complying with Federal Election laws. Virginia must submit to the Supremacy Clause of the Constitution. Ever read the supremacy clause? No! Well, let's fix that!

The state's effort to have the case dismissed failed, and the ongoing litigation was joined by the Public Interest Legal Foundation, and the DOJ began showing interest in the case after the November 2024 election brought a New Sheriff into DC. All of this prompted Oregon's Secretary of State to announce in January 2026 that they would resume the lawful mandate to remove all inactive voters from their rolls—Oregon is clearing out 800,000 inactive names.⁸

Judicial Watch efforts have contributed to the clean up of over five million “dirty voter names” from voter rolls, but there are 24 million names to go.⁹

Remember Lindell, the pillow guy? He has spent 100 million dollars fighting Dominion since the 2020 election. Dominion has been sold to a new owner; it's now called Liberty Voting! From Dominion, to Liberty! That's interesting. are the odds in Las Vegas on Maduro blowing the whistle on how he stole Venezuela with the Dominion system? Well, we'll see! So, it turns out that Coomer admitted, under oath, that he did have conversations with foreign countries. He admitted to discussing Dominion's equipment capabilities and vote adjudication software — remember that? That's about the business of allowing an election worker to review digital images of ballots flagged for “unclear voter intent,” allowing the reviewer to “resolve” voter intent and make corrections on the ballot.¹² Now, why do you suppose a foreign dictator, like Maduro, or his team of thugs, would be interested in that feature? And, you probably already know that the FBI executed a search warrant at Fulton County Elections and Operations Hub, near Atlanta, on January 28, 2026. The FBI took about 700 boxes containing original 2020 ballots, tabulator tapes from the machines, voting images, rolls, and other documents. But it's the reaction of the Fulton County officials that is totally unsurprising to me: They became hostile, calling it "political theater," "retribution," and an attempt to "undermine trust in elections."
