Four RINOS, the same four as before, defeated Senator Kennedy’s amendment to include the following core provisions of the SAVE AMERICA ACT in the Reconciliation Bill: proof of citizenship to

register, and photo ID to vote: Susan Collins (R-Maine), Lisa Murkowski (R-Arkansas), Mitch McConnell (R-Kentucky), and Thom Tillis (R-North Carolina).

I saw a two-headed snake at the LA Zoo some years ago. I thought, looky there, a snake assembled by Committee. It must have been Congress since it can't decide which way it wants to go.

I respect and applaud Mike Johnson's courage to try to get this done for the American people. Nevertheless, the Reconciliation path requires that whatever is included in it be directly related to the budget. Maybe they could have included in the SAVE AMERICA ACT special funding for enforcement of the ACT, or Federal funding to assist States' implementation of the ACT, but with the current Parliamentarian, Elizabeth MacDonough, it's unlikely that anything related to the SAVE AMERICA ACT would be allowed.

For example, the Congress has ruled against using tax revenues to fund abortions. Obama-Care (the Affordable Care Act) includes funding Planned Parenthood, which funds abortions. Lizzy disallowed a provision in the 2017 reconciliation Bill to remove funding from Planned Parenthood on the grounds that it VIOLATES the Law—meaning, the Byrd Amendment. She disallowed it because, in her opinion, it was a “policy” issue, not a funding one. All funding is policy-related.

The question was whether the Affordable Care Act (ACA) could be used by baby murderers to fund the shedding of innocent blood with tax revenues. She injected herself into this on one side of policy, when the issue at hand was conformity to current Law, the Hyde Act— no tax money for murdering babies.

Elizabeth MacDonough invoked the Byrd Amendment to protect budget abuses under the Hyde Act, preventing Congress from correcting an abuse of the current funding law in its reconciliation bill. It seems to me Lizzy either got lazy, or, more likely, she cares more about protecting funding for Planned Parenthood's regular

violation of the sanctity of life in the sanctuary of the womb, than she does providing security to the taxpayer who provides the budget, by allowing Congress to protect the sanctity of our elections in the sanctuary of the voting booth. She would use the Byrd Amendment to contradict the Hyde Act.

The House passed a Reconciliation Bill, and the House Parliamentarian, Jason Smith, declared no objections to including the S.A.V.E. AMERICA ACT in the House Reconciliation Bill.

I understand that House rules are different from Senate rules. The Byrd Amendment is a policy that governs only the Senate. The House Parliamentarian, however, does evaluate Bills relative to the law and must have anticipated that this challenge would come up in the Senate, unless he had no reason to think it would! While the House Parliamentarian would not be expected to “rule” on the Bill’s agreement with the Byrd rule, nevertheless, he is a Parliamentarian, and serves the House, and would likely have evaluated whether it would pass Constitutional muster, and also would have given some consideration to Senate rules in his advice.

Maybe Jason sees what I see. Maybe he does not think an effort to protect the sanctuary of the voting booth, and the sacred right of WE THE PEOPLE to decide who holds power in this country and spends our money, was insufficiently ancillary to the Reconciliation Bill and budget concerns: since, after all, we are talking about protecting the interests of THOSE WHO PAY THE BILLS. I guess he figures the PEOPLE whose money is being SPENT, have a RIGHT to decide who spends it, and so must have access to free and fair elections to decide who spends their money. Yeah, I think that would be germane to any budget considerations. In fact, I would argue that is the number one budgetary concern.

Jason just might be a WE THE PEOPLE defender, and Elizabeth, it appears, is a WE THE SENATE defender.

Maybe these Republicans who voted to bar inclusion of the S.A.V.E. AMERICA ACT are fearful that if their boss, THE PEOPLE, are actually able to exercise their power freely through fair and honest elections, that would somehow be a threat to their power. Maybe they see it as a threat to their seat at the thieves' table. Maybe people like Mitch and Thom, who are on their way out anyway, just hate America and despise the principle of CONSENT OF THE GOVERNED.

Maybe it's just another example of TDS. Anyone suffering from Trump Derangement Syndrome cannot reason on the basis of right and wrong, good or evil. Everything is cast into the categories of something Trump wants or it's something Trump does not want. If Trump wants it, they don't. If Trump does not want it, they do. Their ego is so fragile that they feel a total loss of self if they support something Trump wants, and their rationale is limited to that one criterion: because Trump wants it.

Here is a simple example that makes this easy to see. Fired, former Trump National Security Advisor John Bolton was indicted on 18 counts of mishandling classified information. He has agreed to plead guilty³ to one count of retaining classified documents. He will pay 2.25 million in fines and penalties and faces a possible 5-year jail sentence unless his attorneys can convince a judge to impose a lighter jail term. These are the straightforward facts — but Reuters et al., present the case as against John Bolton, the Trump critic, and frame it entirely around the idea that Trump's DOJ is casting out all precedent and using the government to get vengeance on his critics. This is outrageous! But, we are getting used to it.

My audience knows what happened during Trump's first term, the coupe against a sitting President, orchestrated by Hillary as a

campaign slur, with manufactured accusations of collusion with Russia—and I mean it was a totally fabricated story. When Trump won, Obama picked it up to use it in a coupe attempt against a duly elected President by WE THE PEOPLE. Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse, your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church belfry arch, signaling the

enemy is on the march—an enemy that would steal from us our liberty.

While we are talking about election integrity, let's take a look at what's going on in California right now.

The results as of 64% of votes counted has Bass at 35, Pratt at 29 for the LA Mayoral race. With 60% of the vote counted Statewide, Steve Hilton at 27.2, Becerra at 26.0, and Steyer at 20. Our friend Bianco is at 11%.⁴ That was this morning. This evening, Becerra has edged out Hilton by a fraction: 26.7% versus 26.4%, with Steyer at 21%. So, let's see. As votes continue to be counted, Steyer moved up one point, Becerra moved up a little over 1.5 points, and Hilton slipped almost one point. We've all seen this before. I know, I know, CA law allows any ballots received after election day to be counted so long as they are postmarked on or before election day. The universal mail-in-ballot system is simply too vulnerable to fraud, especially with corrupt election registration, and voter rolls full of dead people, and all that junk.

First, most States count their entire election within hours of polls closing. Why is CA so backward that it cannot count ballots in a timely manner? Florida counts 10 million votes in a single night. California takes weeks.

Second, two factors cause delays, creating room for voter fraud to skew election results:

The universal mailing of ballots, distributed to everyone on the list, without any vetting, and the drop box system, which can allow deposits after polls close at some drop boxes.

These ballots do not have to be time-stamped, and there is no mechanism that automatically time-stamps inserted ballots or

closes and locks the boxes at 8 PM. Let's clamor for that and see how they respond.

The other issue is signature verification. If we are going to use mail-in ballots or Dropbox-delivered ballots, signature verification is necessary.

Someone, ostensibly trained in identifying a signature match, examines each ballot envelope before the votes on that ballot are counted. This is first level evaluation is done by machine in some counties; that would be programmed with signatures on record and, sort of like face recognition, zip through the comparison samples, sift out those where there is a question, and then have those looked at. No! CA has a person examine every ballot against samples from the voter registration card, DMV records, or "other election records." You've got to be kidding me. And that's only the first level; if the first-level examiner is uncertain, it is escalated to a more experienced reviewer or supervisory personnel. If the signatures don't "match," there is a "cure" process. The voter is notified and given an opportunity to submit documentation confirming their signature. This involves a signed affidavit or a signature verification statement.

At NO POINT is the voter required to prove anything! If they know they are voting in place of someone who has died, they know no one will challenge their vote.

These people are allergic to providing proof of identity. Why?

Oh, there is a third issue contributing to a major vulnerability to fraud: CA does not allow a single vote to be counted until after the polls close at 8 pm on election day. Most states count early and mail-in votes before the election.

So, this whole thing is crazy, but we are "ruled" by unreasonable and wicked people. If we had in-person voting, showing photo-ID at the poll, dropping the completed ballot at the polling station,

these could be periodically gathered and counted as the voting day proceeded. If the voter rolls were reasonably maintained and clear of dead, deceased, or vacated voters, we would not require two to three weeks to count ballots. And the people of California could have confidence in the election results.

Only someone who benefits from a messy, complicated system full of vulnerabilities to election fraud would opt for the system used in California.

Anyone can use any address to register to vote. They need no voter ID or any proof of citizenship. There is no statewide requirement that every ballot dropbox be under 24/7 video surveillance.

Fraud is encouraged by this in the same way that if you leave your wallet on the front seat, or dashboard of your car, with a 100 dollar bill exposed, and the window down, and wonder who would come along and reach into your car and steal your wallet, what can I say? You are a Macaroon!

I think capacity is an important qualification for exercising the judgment necessary to guide the governance of our country. If you don't have sufficient capacity to secure an ID and establish responsible residence in the community, I mean, beyond a toilet address, really, if someone is on the government dole, if the only interest they have in voting is when someone, like Brenda Lee Brown Armstrong comes to their sidewalk camp, on skid row, with their Cartabago full of cans and junk, and offers them some drug-dollars, or booze-bucks for their signature on a voter registration form with her address so she would receive the ballots.⁵ You understand that this woman is being prosecuted on Federal charges of voter fraud, and that these people have insufficient capacity to participate in our elections.

But capacity is a legitimate concern, and it has long been established in our election laws. Which is the reason corrupt parties, whether they are Democrats, Republicans, Independents, or the Communist Party of the USA—recruit these people who do not have capacity to act in their own interests or in the interests of others, people whose interests are limited to getting their next fix, and then these fraudsters come along and use their vote to multiply their own influence in an election unfairly—literally stealing the votes of their neighbors. That's why they go into the slums and register homeless drug addicts to vote, then collect their ballots, and use them to amplify their vote. All of this is stopped by citizenship registration, voter ID, paper ballots distributed at the polling station, and election Day voting!

We need the S.A.V.E. Act NOW!

Here is a Fox11 LA news post headlined: “Election fraud probes in California announced by US Attorney amid rising tensions over slow vote count.” [IBID.] That's not the only concern. We'll have to wait for it, but the slowness of counting is concerning, but it's not the problem. It's the election fraud that's going on during the delayed count. The “First Assistant U.S. Attorney Bill Essayli announced that his office has opened multiple election fraud investigations in coordination with the FBI.

today (June 5, 2026), the Pentagon reports, U.S. forces boarded a sanctioned oil tanker.⁸

According to TankerTrackers.com,⁹ the ship is carrying almost 2 million barrels of Iranian crude. [IBID.] This cargo was loaded onto the Davina (aka Lenore) at Kharg Island on March 20. It departed from the Strait before the U.S. Blockade, and has been “evading detection off the coast of Sri Lanka for the last six weeks.” [IBID.] On June 5 (today—Friday, show prep day) U.S. Central Command reported we have rerouted a total of 129 commercial ships, and disabled 6, enforcing the U.S. Blockade of Iranian shipping and ports. Here is the official U.S. statement from U.S. INDOPACOM (Indo-Pacific Command):

“Overnight, U.S. forces carried out a maritime interdiction and right-of-visit boarding of the sanctioned stateless vessel MT DAVINA located in the Indian Ocean within the INDOPACOM area of responsibility.

We will continue global maritime enforcement to disrupt illicit networks and interdict vessels providing material support to Iran, wherever they operate.

International waters cannot be used as a shield by sanctioned actors. The Department of War will continue to deny illicit actors and their vessels freedom of maneuver in the maritime domain.”¹⁰

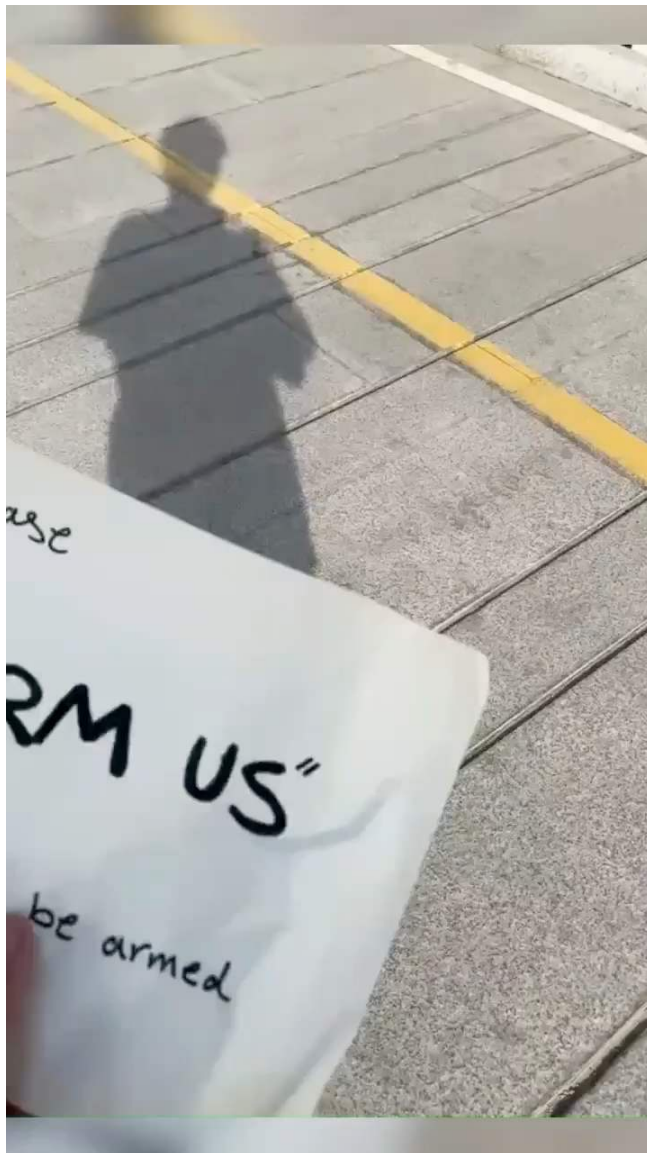
